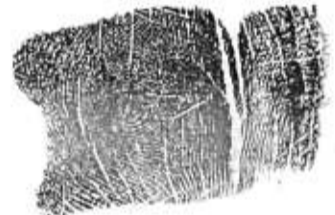

ADMINISTRATION

6. The trust shall have board of trustees consisting of 5 persons. The founder trustee K.P.Abdulrahiman will be the Managing trustee of this Trust for his Life time. The other trustees shall hold office for a period of five years.
7. The Board of Trustees shall have a Chairman, Managing Trustee, Treasurer and 4 members.
8. The Board shall have power to form Managing Committees for each institution and accordingly the founder had nominated the Managing Committee for Ideal Public School consisting of 15 persons.
9. The founder shall be the Managing Trustee of the Board till his death or till his retirement after the death of the founder the all office bearers shall be elected by the Board of Trustees. If any vacancy arises by the Board of Trustees the Founder reserves the right to nominate and after the death of founder, by majority decision of the Board.
10. The terms of the office bearers of the Board of Trustees shall be 5 years or till new office bearers of elected. The founder reserves the right to select the office bearers till his death.
11. The bank account of the trust shall be operated by the Managing Trustee till the founder retires the office. Subsequent to that the bank account shall be operated by the Chairman and Managing Trustee jointly.
12. Power and duties:-
- (i) Chairman: He shall preside over the meetings and also all acts to supervise the administration of the trust.

ADMINISTRATION

(ii) Managing Trustee: He shall be the Chief Executive of the Trust. He shall represent the trust before the Government, Court of Law and all other Departments. He shall have all powers to manage appointments and dismissal of the staff. He shall keep true account of the trust. He will keep the amount in the Bank entrusted by the Managing Trustee.

(iii) Treasurer: Treasurer shall be elected from the members of the Board Trust. He is the responsible person for maintaining cash.

13. The Board of Trustees may for the purpose of assisting it in its functions form Advisory Councils consisting of experts in various fields from amongst themselves as also outsiders.

14. The Board of Trustees shall meet once in six months or as required from time to time.

15. The quorum of the Board shall be minimum 3 members.

16. The properties acquired by the Trust shall be always in the joint names of the Chairman and Managing Trustee of the Trust.

17. No property of the Trust shall be disposed off without the sanction of the Board of the Trustees by a resolution passed at a meeting of the Board of Trustees.

18. The proper books of accounts shall be maintained by the Trust and the same shall be audited by a Chartered Accountant, appointed by Board of Trustees.

19. The Board shall frame the rules and regulations for the smooth functioning of the Trust.

20. The Board of Trustees may constitute sub committees for different purposes and shall delegate any or all of its powers to such sub committees.

21. All amendments of the Trust Deed shall be a majority of the Board of Trustees at the Annual Meeting or a meeting specifically held for the purpose. But no amendment shall be made without the approval of the Commissioner of Income Tax.

22. The Trust hereby created is an Irrevocable Trust.

23. If for any reason the Trustees feel that they cannot carry on the objects of the Trust themselves, they shall transfer the funds of the Trust then available with its obligations and liabilities to any other Trust or Charitable institutions having similar objects and the decisions of the Trustees in this respect shall be final.

24. In the matters which are specifically stated herein the provisions of the Indian Trust Act shall be made applicable.


